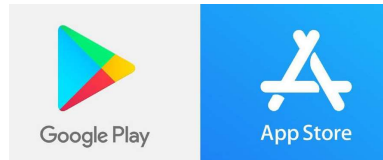

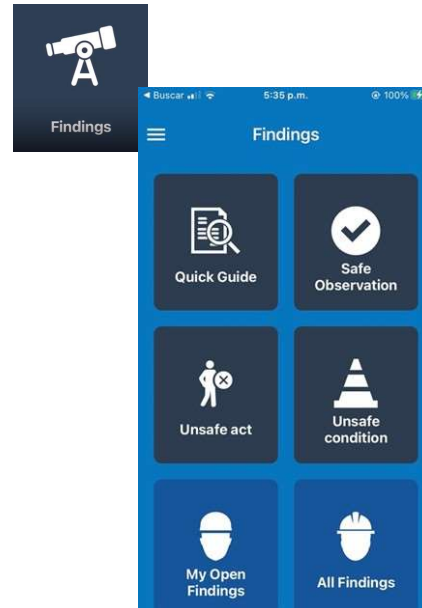

4. Definitions

Term	Definition
Unsafe act	Actions performed by the employee that imply an omission or violation of a work method or measure determined as safe.
Mobile App	A mobile application, most referred to as an “app”, is a type of application software designed to run on a mobile device, such as a smartphone or tablet computer
Unsafe condition	Conditions resulting from the non-observance of the measures established as safe, and which may lead to the occurrence of an event.
Entity	That identifiable unit that carries out economic activities, constituted by the combinations of human, material, and financial resources (integrated set of economic activities and resources), led and managed by a single control center that makes decisions aimed at fulfilling the specific purposes for which was created.
Finding	Unsafe act and unsafe conditions
SI	Sempre Infrastructure
Subsidiary	Entity over which Sempra Infrastructure is a shareholder and, in some way, can be said that has “control” over the Entity. Sempra Infrastructure shall be understood to have control of an Entity if it has the capacity to execute any of the following acts: (i) impose, directly or indirectly, decisions in the general meetings of shareholders, partners or equivalent, or appoint or dismiss the majority of the directors, administrators or their equivalents of an Entity; (ii) maintain the ownership of rights that allow, directly or indirectly, to exercise the vote regarding more than fifty percent of the Entity's capital stock; or (iii) direct, directly or indirectly, the administration, strategy or main policies of an Entity, whet
HS	Health and Safety

The above terms may be used in the singular or plural, as well as in the masculine or feminine form depending on the context of this policy.
