In April 2015, we created Fundación IEnova, A.C. (Fundación IEnova) because we are strongly committed to contributing to the wellbeing of the communities to which we belong. It is a second-tier foundation duly authorized to make donations and economic contributions in compliance with the requirements set forth by the Mexican Internal Revenue Service (*Servicio de Administración Tributaria, SAT*).

Through Fundación IEnova's work, we strive to maximize the positive impact of our activities on the communities where we operate.





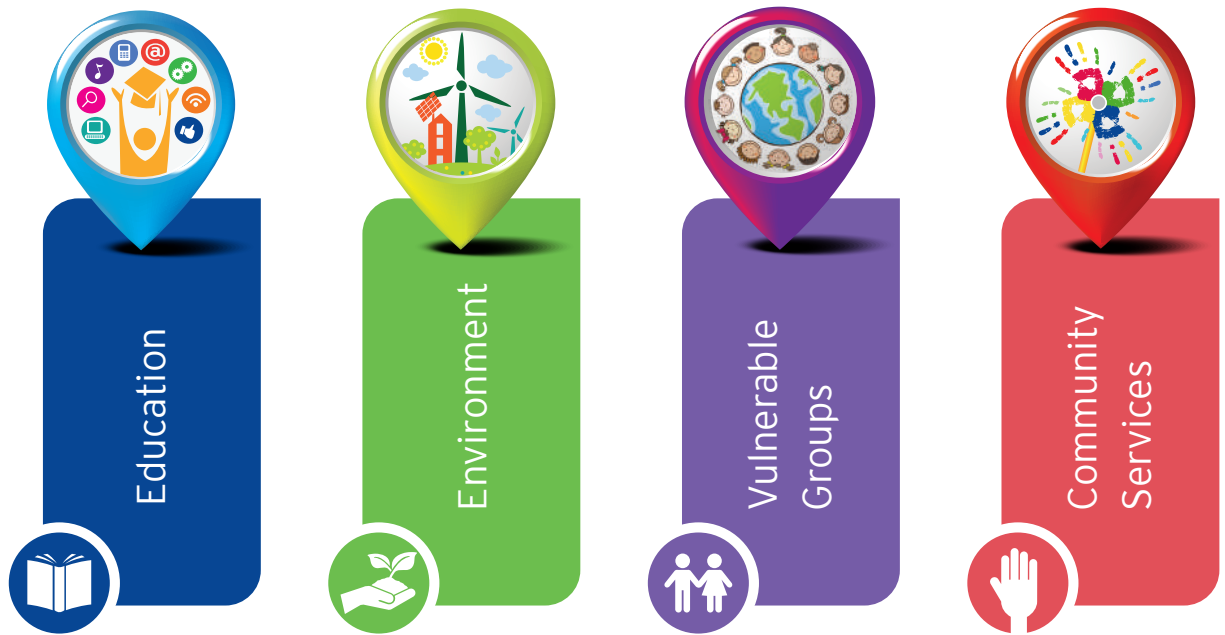
Our Mission

At Fundación IEnova we are committed to transforming lives by supporting organizations and programs that contribute to the growth of the members of the communities to which we belong, and to preserving the environment.



Action Pillars

We focus on projects that offer greater mid- and long-term benefits to the community, and that are congruent with the **four pillars** sustaining the Foundation's activities:



Methodology for Granting Donations

Fundación IEnova supports non-profit organizations that are SAT-approved, and whose activities align with the social goals described in its bylaws.

We have designed an assessment methodology to structure the way in which we evaluate projects and organizations. Our management team follows this methodology when selecting the organizations that will receive donations. In addition to transparency in the donation process, this enables us to maximize the impact of the allocated resources.

Applying the Methodology

Each of the applications is thoroughly analyzed. Both the entity and the project are evaluated. By employing this methodology, we can assess how sound an organization is. Included in the review are factors such as corporate governance, transparency, experience, recognitions, and sustainability efforts. We also analyze the problem that is being addressed by project, location, performance indicators, potential results and impact, and sustainability-related plans, among others.





Organizations with the best scores are pre-selected to receive a donation. These are then subjected to an anti-corruption practices authorization process in accordance to the Foreign Corrupt Practices Act (FCPA), the Corporate Ethics Policy, and the IEnova Anti-Corruption Procedures for Donations, Memberships, and Improvements. Afterward, the list of selected organizations is shared with Fundación IEnova's Managing Board and Advisory Committee for final approval.

Once authorized, we sign a collaboration agreement with the selected organizations establishing the conditions that need to be met in order for a donation to be granted.

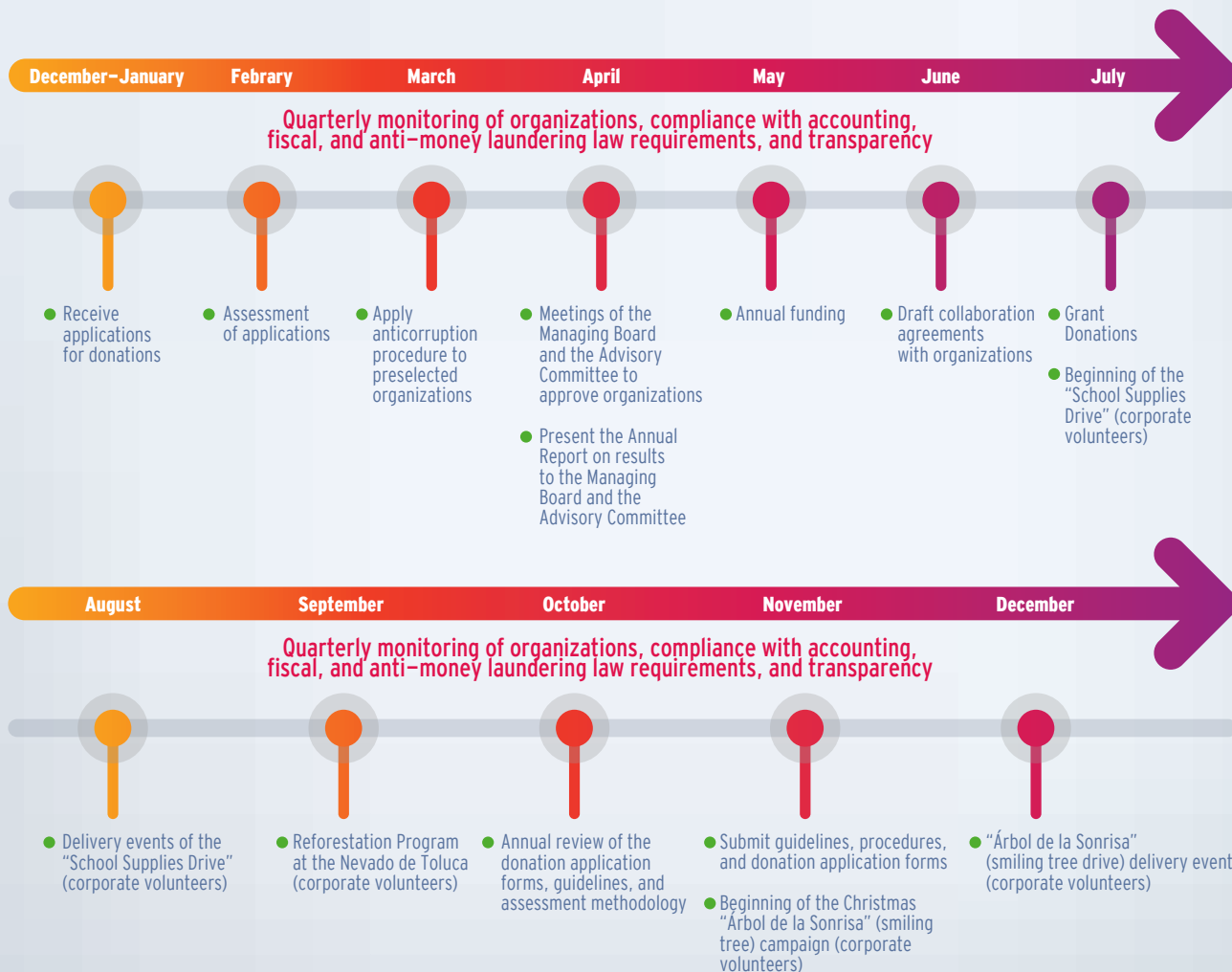
In July of every year, the corresponding monetary amounts are electronically transferred to the selected organizations. During the year of operation of the grant, or until the allocated economic resources are completely used up, the organization must submit quarterly reports as well as the supporting documentation needed to verify compliance with the established timetable and conditions. The procedure is based on the stipulations of the Procedure for Applying and Granting Fundación IEnova Donations.

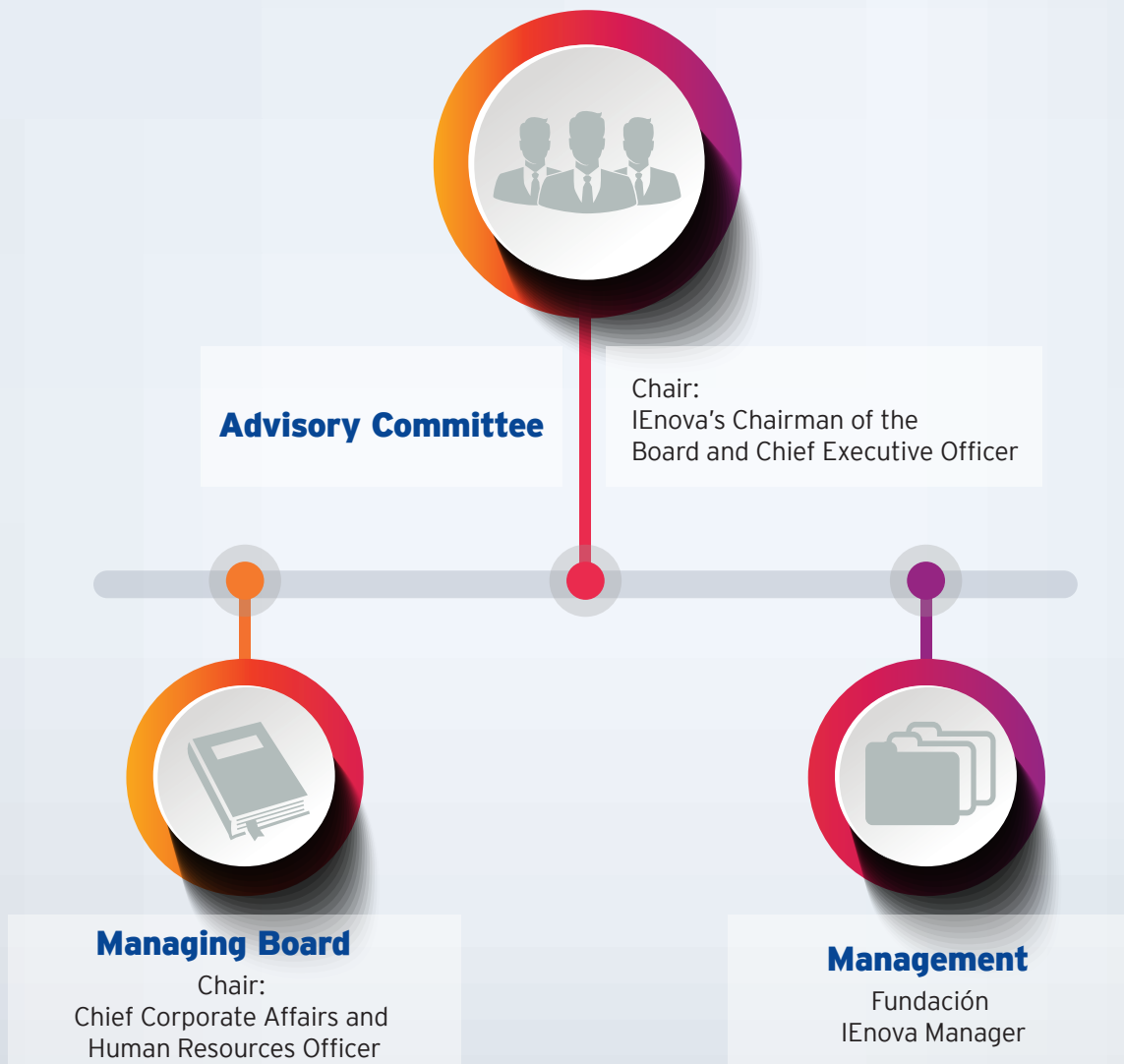
Corporate Governance at Fundación IEnova

Fundación IEnova is supervised by an Advisory Committee and a Managing Board. The Advisory Committee includes Company Vice-Presidents and is chaired by IEnova's Chief Executive Officer and Chairman of the Board. Several employees are members of the Managing Board and it is chaired by the Chief Corporate Affairs and Human Resources Officer.

The Fundación IEnova management team submits a list of pre-selected projects to the Managing Board for endorsement. Projects endorsed by the Managing Board are then submitted to the Advisory Committee which meets to assess and, if applicable, approve the projects and organizations chosen to receive the donations. It also evaluates the results of the projects, supervises the performance of the Managing Board, and evaluates how Fundación IEnova is being managed.

Operating Results

In 2015, the authorized budget was **USD\$200,000**, and in 2016 the budget was increased to **USD\$500,000**, enabling us to increase the benefits of our programs.

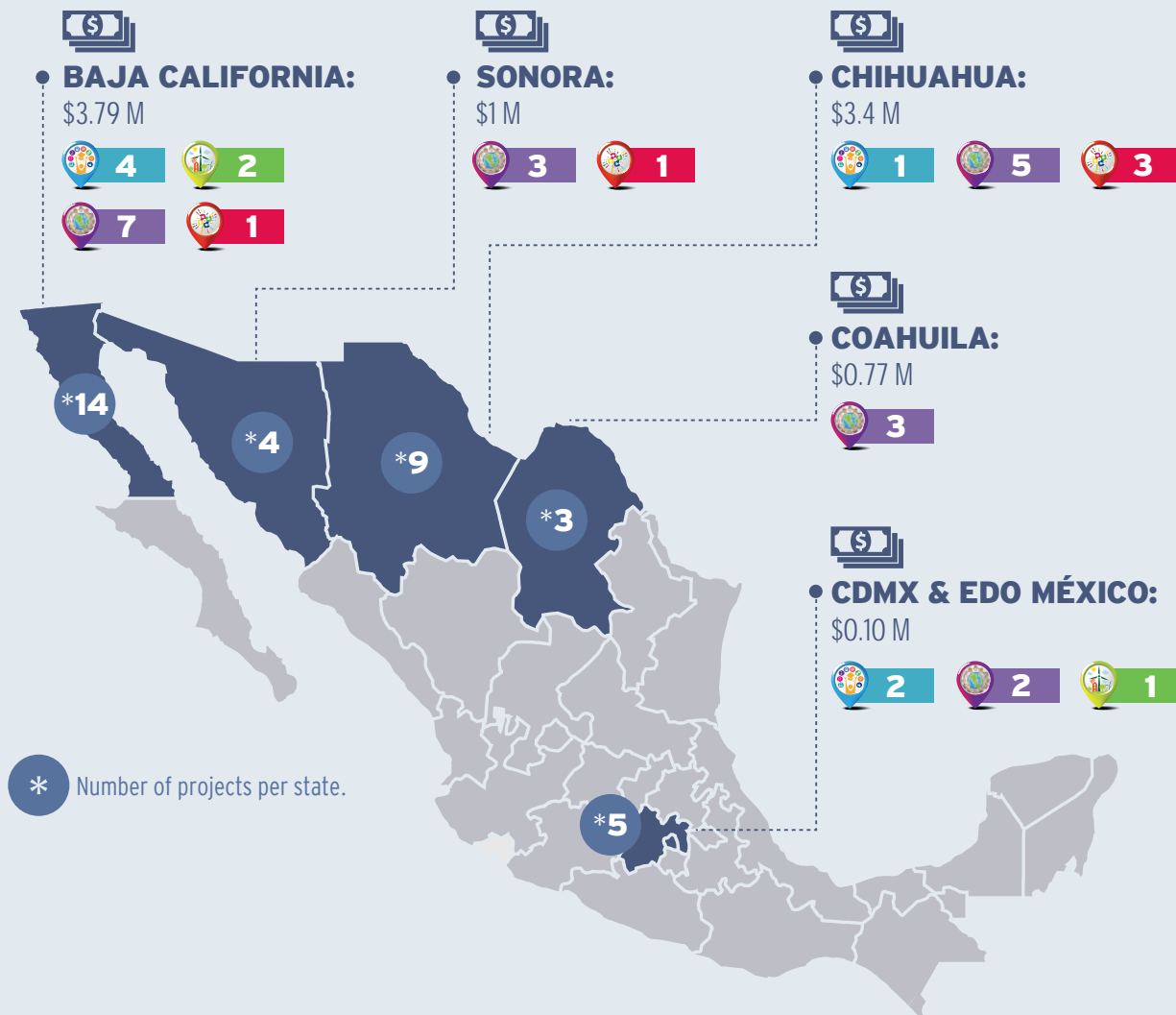

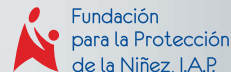

Since 2015, as part of our partnership with the *Fundación para la Protección de la Niñez, I.A.P.*, an organization that helps vulnerable groups all over Mexico, we adopted six foster homes for children living under vulnerable conditions in locations where IEnova has operations, such as Hermosillo, Mexicali, Ensenada, Torreón, Chihuahua, and Mexico City. By developing infrastructure-improvement projects we wish to contribute to changing the living conditions of these children and to offer them better opportunities for a better life.

- *Escuela + Sonrisas*, benefited approximately **376 children in 6 cities**: Mexicali, Ensenada, Hermosillo, Chihuahua, Torreón, and Mexico City.
- *Árbol de la Sonrisa*, benefited approximately **438 children in 7 cities**: Mexicali, Hermosillo, Chihuahua, Torreón, Mexico City, Monterrey, and Ciudad Juárez.
- The Reforestation Program at the Nevado de Toluca, adopted a half-hectare plot on which **500 trees** were planted, with the collaboration of **65 employees and their families**.

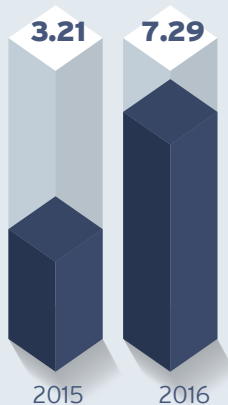
